Noted that fleet cover under this policy automatically stops on the date that the vehicle is sold or stops being leased.	<ul> <li>Page 13</li> <li>7.1 You are not covered for fleet vehicles once they are sold or the lease ends</li> </ul>
Removed reference, cover and exclusions related to the Forest and Rural Fires Act 1977.	Throughout the Commercial Motor Vehicle policy
